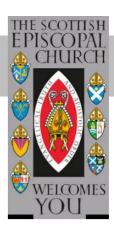

REPORTS

Church

We have 84 members on our congregational roll. We have 72 on the Communicants Roll as defined by Canon 41.2. It has been good to welcome several new members as well as many visitors during the year.

We have not had any baptisms or weddings in church in the past year, though there have been some enquiries for next year and one wedding was conducted in the QEU Hospital. Since the last annual meeting we have conducted seven funeral services in church and local crematoria and there have been three burials of ashes in the memorial garden. We are grateful to Alexander Roach for volunteering to help prepare plots for burials of ashes.

Highlights of the past year have included welcoming our new diocesan Bishop, the Rt Revd Nick Bundock, who now lives in Bearsden; a Harvest Thanksgiving service at which Bishop Nick celebrated and preached; a number of ecumenical events, with services held together with New Kilpatrick (both at All Saints and at NKP church) at Advent, Christmas, and Holy Week; and a unity lunch in February.

The Rector has led a number of services at Abbotsford House care home during the year. He has also made visits to other care homes by request.

It has been disappointing not to be able to build up links with children and young people, though they are welcomed and encouraged when they do come to church. This year we are looking forward to hosting a Nativity play by children from the Maxholme Nursery and it is hoped that further links may be developed.

We held another successful Prayer and Giving Day in May. This led to the revision of the prayer diary for the church, with suggestions for prayer for each day of the week. The weekly prayer group meeting before Wednesday Communion services continues using Morning Prayer as a starting point.

We have valued and much appreciated the continuing support and involvement of Revd Kevin Francis during the year, as a member of the congregation with Sharon, helping at services, and covering during the Rector's holidays.

The Rector is always willing to visit people in home, hospital, hospice or care homes if made aware of a need and will happily take home Communion if requested.

In addition to the regular house study groups (reported on elsewhere) we held study groups in the hall for Advent and Lent shared with St Andrew's, Milngavie, who also join us for occasional services.

We have maintained our pattern of regular Sunday services (the 10.30am Communion attracts a range of congregation numbers from 25 to 60+!) with an evening service from time to time for special occasions. We livestream our 10.30am service on Facebook each week, though this continues to be challenging because of poor connectivity to Wi Fi/mobile signal. The service is also uploaded to our You Tube channel. The Facebook livestream usually attracts between 50 to 100+ viewers live and later each week, with more than 50 weekly on You Tube.

We made donations of toys at Christmas to Glasgow Children's Holiday Scheme and Aberlour and were pleased once more to take a significant number of goods collected at Harvest to Drumchapel Food Bank in addition to regular deliveries there during the year, as reported elsewhere.

It was a particular pleasure to welcome Willan Kalinda to preach at a service in October. Willan was born at the David Gordon Memorial Hospital in Livingstonia, Malawi, which we have supported as a church for over 20 years, and he continues to serve as a board member. He is also country director of the Scottish-based Bananabox Trust and a special collection was held to raise funds for their work.

The Vestry has expressed great sadness at the death of Professor Andrew Long who served the Vestry for many years in a number of roles, most recently as Treasurer.

The Vestry warmly welcomed Dolina Dowling as a new member of the Vestry and thank her for taking the role of acting Vestry Secretary for six months.

Andrew Roach ends his term of office this year and we thank him for his hard work on our behalf during his period of service. There will be an election for a new member at the Annual General Meeting. There is also an outstanding vacancy not filled last year.

We are grateful to David Hamblen, who generously extended his period as Alternate Lay Representative. He has indicated that, while continuing to serve on the Vestry, he wishes to stand down from the ALR role, so there will be an election for his replacement at the annual meeting.

Lay Representative report for AGM, November 2025

Thankfully the last 12 months have been much more positive for me than was the case last year. Here is a brief summary of my recent activities. As your Lay Representative I have a number of roles to undertake. The first of these, encapsulated in the older name of "Lay Elector," is to be your representative at Diocesan Synod (Electoral and otherwise). Since the last AGM, as many of you know, we used newly-revised Canon IV procedures to elect a new bishop. Following on from the preliminary meeting of the Electoral Synod on 21 st September, 2024 (as I reported last year), we had two further meetings. On the first (on Saturday, 11 th January) the shortlisted candidates each gave a presentation, focusing on their visions for the Diocese of Glasgow and Galloway, and were asked a series of questions. In the second (on Saturday, 18 th January), we were required to vote. As you all know now, the electoral process ended up with our very own Bishop Nick Bundock being elected and, over the course of the year, moving into Bearsden to be our neighbour. I must say that one of the highlights of my year was Bishop Nick's Consecration at St. Mary's Cathedral on Saturday, 3 rd May. If you want a fuller account, please read my magazine article about this (June, 2025), but it was certainly both an enjoyable and an inspiring occasion. The Diocesan Synod this year was on Saturday, 22 nd February, in Kilmarnock. It was a strange one this year because it was before Bishop Nick's consecration, so, despite the sense of excitement and expectation there was a strong sense that business was "on hold". All Synods this year (except for a short, extraordinary online one to approve some emergency changes to Canon IV which David Hamblen, Alternate Lay Rep, attended on my behalf) were chaired by Bishop Andrew, the Bishop of Brechin, with his usual good nature and efficiency. This was much appreciated by Synod members.

There have been a number of high-profile retirals at Diocesan level over the last 12 months. Long-serving Diocesan Secretary John Mitchell, and treasurer Bob Burgon, both stepped down, as did Christine Hughes, after many years working in the Diocesan Office. Rev Canon Audrey O'Brien Stewart also resigned as Canon Missioner, although has now thankfully returned to the Diocese as Priest-in- Charge at St. Cyprian's, Lenzie. One of my other roles on your behalf is attending meetings of the North-West Regional Council (NWRC). We rotate around the region for these and have enjoyed meetings at St. Augustine's Dumbarton, St. Andrew's Milngavie and St. Michael's Helensburgh in the last 12 months. These meetings no longer have any official role in terms of Diocesan governance but serve as a useful forum to discuss important issues and share news from around the region. Often, we enjoy fantastic catering at these events too (the Lay Rep role seems to involve quite a lot of eating and drinking)! One small change at the last AGM in January is that Rev. Andrea Hagenbuch stepped down as Chair and we now have Rev Dom Ind of St. Michael's, Helensburgh. I have stayed on as deputy chair though, and Tim Rhead of St. Andrew's Milngavie is still secretary. Another change is that Rev. Sydney Maitland has now retired as priest-in-charge at All Saints, Jordanhill, but this is thankfully, currently, the only vacancy in the region. I have pleasure to note that the tone of these meetings has become considerably more upbeat in the last 12 months, and especially since the beginning of Bishop Nick's episcopacy.

There are small signs, I think, of growth and innovation in churches across the region. I hope that these will continue over the next 12 months. I very much enjoy my role as your lay rep, especially meeting my friends from across the Diocese at Synod and regional councils. More details of the meetings I have attended over the last year are available in my regular magazine articles.

PVG Co-ordinator AGM Report 2025

April 2025 saw the implementation of the new Disclosure (Scotland) Act 2020 into Scottish Law making it now a legal requirement for all those working in regulated roles with Children and Protected Adults to have PVG membership. All those who currently require this for All Saints are covered. April 2026 will see the end of PVG membership for life with the introduction of a time limited membership with a 5 year renewal cycle. I will follow up with anyone this may affect.

There have been no safeguarding issues raised over the last year either by the congregation or hall users but please be reminded that we all have a duty of care to foster a safe and supportive culture for all in the church community. There are notices with contact details if anyone has any concerns on both the Church and the main hall notice boards.

Property

During the past year a number of improvements have been made to the Church estate:

- 1. access to the car park has been improved by the removal of the gates
- 2. the stained glass window above the altar has been restored, by virtue of an appeal generously supported by the congregation. These works were managed by Susan Gray as property convenor until mid-way through 2025, for which much thanks. Susan also managed the survey of the bellcote and contributed to the Vestry's decision to go ahead with its full repair. Work was originally planned for December. After concerns were raised by the Vestry about possible disruption to activities in the Church in the run up to Christmas, the steeplejacks have agreed to postpone the work until later in 2026, when the weather may be more suitable and to avoid construction noise during December. Applications have been made for grant funding for this work. Subject to the success of these, some support from the congregation may be required to fund the bellcote repair.

The break-in at the end of July caused some upheaval and damage. A window in the Choir Vestry was smashed and a fire extinguisher was used to break down the Sacristy door. The break-in necessitated the replacement of all the locks and keys for the Church and Halls. Communication with the contractors appointed by the church's insurers has been difficult at times, particularly in the matter of the type and number of replacement keys. A decision was made to retain the replacement lock for the Hall as a large number of duplicates had already been cut and distributed to hall users. The Sacristy door has been replaced, but awaits painting to match the panelling of the Sacristy interior. At the time of writing, replacement of the broken window and replacement of other locks is due to take place on 3 November, which should complete the repairs arising from the break-in. On police advice an additional security camera has been fitted and further improvements to security have been recommended.

At the Rectory hedge cutting and shrub trimming have taken place and a regime is in place for this work next year. The gutters have been cleared. Some work is required to improve the performance of the central heating at the Rectory.

Sometimes when I trundle up to their premises Old Mother Hubbard is looking quite anxious, if not decidedly flustered and it is so rewarding to see the evident relief on her face when I turn up with our All Saints offerings.

What I take along is, quite honestly, just a drop in the ocean of their ongoing needs and I wonder if I could make an appeal for even greater support at this time of ever-increasing demands on our disposable incomes. I would ask you all to think very carefully and enquire of yourselves whether you could buy an extra item, or even two, of staple grocery items to help out those who are so very much less fortunate than we are. Whatever items we donate are things that those whose circumstances forces them to rely on the Food Bank won't have to purchase themselves. I have been accused of cynicism, (yes, really?) in the past and there was a period when I might have said that what we provided perhaps left recipients with more of their welfare money to pursue lifestyle choices that we may not have agreed with or condoned but honestly, I don't believe this is true in the vast majority of cases and at the end of the day, to use that old quotation, there but for the grace of God go you and I.

Whatever you donate is gratefully acknowledged by our friends in the Drumchapel community and by the representatives at the Food Bank and I echo their gratitude as I have the pleasure of witnessing this when I make the deliveries of **your** donations.

FINANCIAL REPORT TO VESTRY

OCTOBER 2024 - SEPTEMBER 2025

This report is based on the provisional accounts for the financial year 2024-25, and was approved at the Vestry meeting on 13 October 2025, for presentation to the Church AGM on 27 November 2025.

Also attached are the Statement of Receipts and Payments, Statement of Fund Balances and associated notes which will be handed over to the Independent Examiner for examination following the AGM.

Overall performance

The deficit on the current account for the year 2024-25 was £6,091. However £5,000 was paid to Mission Support during the year, from the surplus in 2023-24. Excluding that item, the deficit for the year would have been £1,091.

Income

② At £42,153, total congregational giving (all 3 categories) was in line with budget and showed a 3% increase from last year. A modest decrease in monthly Bankers Orders was compensated for by an increase weekly Free Will O②ering (envelopes) and open plate cash collections.

Hall donations were £21,062, slightly behind 2023-24 but ahead of budget.

② Actual fundraising in the year includes amounts raised specifically for the Stained glass window (£7,268 before Gift Aid) and the bellcote repairs (£1,027). In addition, a total of £3,846 was raised by Sunshine bags (£745), Da②odil Tea (£450), Prayer & Giving Day (£1,945), Burns Night Supper (£630) and Cakewalk (£76) – in excess of the £3,000 included in the budget. Once again, I would like to add my sincere thanks to all who were involved in organising and contributing to both these events.

2 £16,173 was received from HMRC for Giftaid which was £3,236 more than budgeted

② Other income includes a £1,880 refund from Scottish Power and a further refund is being pursued.

Expenditure

② Major refurbishment costs of £14,450 in the year covered the Stained glass window repairs (£8,748), carpark works (£4,646) and steeplejack initial assessment of bellcote repairs (£1,056). The budget for the year included repairs to the bellcote and painting the outside of the church, neither of which were completed and so will need to be included in the budget for the new financial year.

2 £5,000 was donated to a range of local and international charities under the Mission Support heading.

The quota was budgeted at £14,172 but was actually lower at £10,873.

☑ Investment in SEC UTP, along with some other smaller individual investments were valued at £158,499.

In total this comes to £228,308 which although a substantial amount, once again we need to remember that without fundraising and excluding major refurbishment costs, annual costs are currently exceeding income by c£14k. At that rate, it would only take about 16 years to erode all our reserves.

Finally

☑ Fundraising events will continue to play an important role in narrowing the gap between income and expenditure in 2025-26.

② As outlined above, major refurbishments of repairs to the bellcote and painting the outside of the church have been included in the budget for 2025-2026, estimated at £31,390. Grant applications have been submitted to contribute to the bellcote repair costs, as well as donations already contributed for that purpose, of £1,027. Painting will only be done when further consideration has been given as to how it will be funded.

☑ £5,000 is currently included in the 2025-26 budget for Mission Support, but requires some discussion. In previous years, when a deficit is expected it has been decided not to make payments for Mission Support. We would ask the congregation to consider whether the Mission Support amount should be: o included in the budget as is, resulting in a budget deficit of £10,859 for the year o included in the budget but with fundraising income increased by £5,000 to meet the cost

o excluded from the budget with the intention that payments will only be made if additional fundraising allows
